

A rideshare wreck raises a question a normal car crash does not: whose insurance actually pays. The answer depends on what the driver was doing at that exact moment.

When the app is off, the driver is just a driver, and only the personal policy is in play. When the app is on and they are waiting for a ride request, a smaller layer of coverage generally applies. Once a ride is accepted or a passenger is aboard, a much larger commercial policy typically comes into play.

That timing is not a technicality. It can decide whether the coverage available is modest or substantial, and the records that prove it sit with the rideshare company, not with you.

Whether you were riding, driving another car, walking or on a bike changes the analysis too. Each one can reach different policies.

How much does a personal injury lawyer cost in Atlanta?

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
