

What Is the Anion Gap?

The **anion gap** is a computed value that helps clinicians interpret **serum electrolytes** and identify less obvious problems in **acid-base balance**. It is not directly measured. Instead, it is derived from values typically reported on a **basic metabolic panel** or **comprehensive metabolic panel**, most often using **sodium**, **chloride**, and **bicarbonate**.

In plain language, the anion gap balances the positively charged ions and negatively charged ions in the blood. Because common lab panels do not capture every ion, the calculation acts as a helpful gap-finder for unmeasured acids or other charged particles. 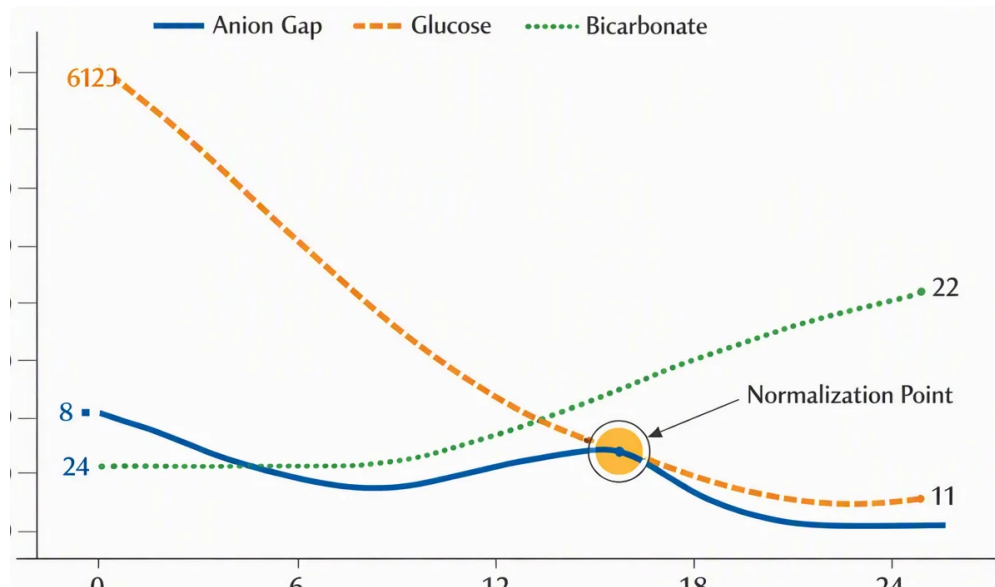
