

When a dog attack leaves someone hurt in Georgia, the legal standard surprises most people.

In some places an owner is liable automatically. That is not the Georgia rule. The claim generally turns on whether the owner had reason to know the dog was vicious, or whether the dog was loose in violation of a local leash ordinance.

Proving prior knowledge is difficult. Owners rarely volunteer that a dog has snapped before, and witnesses on the same street tend to stay quiet.

Local ordinance violations are usually easier to establish, so the early questions focus on whether the animal was restrained and whether anyone contacted animal control.

These records fade fast. Animal control files and recollections both fade, and the animal may be rehomed or euthanized before its history is ever documented.
