

What Is the Anion Gap?

The **anion gap** is a computed figure used in **serum chemistry** to assist in assessing **acid-base disorders**. It indicates the discrepancy between routinely measured positive and negative ions in blood, especially **serum sodium**, **serum chloride**, and **serum bicarbonate**. Because routine lab testing does not measure every charged particle in the blood, the anion gap provides a useful window into the presence of **unmeasured anions**.

In practical terms, the anion gap is a **diagnostic clue** rather than a diagnosis by itself. 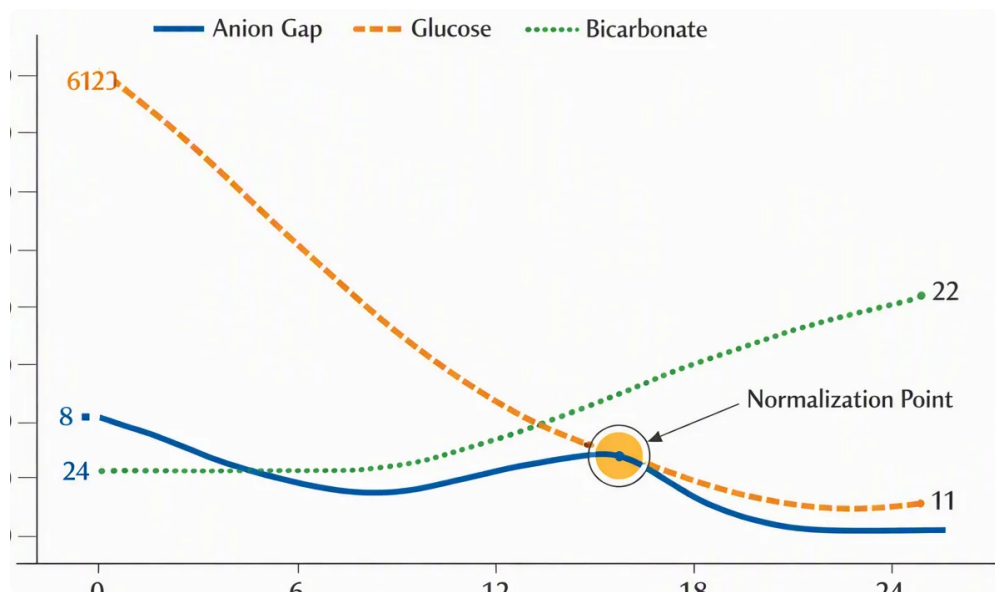
