

If you or your child were bitten around Atlanta, [lawyer for truck accident settlement](#) Georgia works differently than people expect.

In some places an owner is liable automatically. Georgia is not one of them. The claim generally turns on whether the owner knew the animal was dangerous, or whether the dog was loose in violation of a local leash ordinance.

Establishing what the owner knew is not easy. People do not readily admit their dog has a history, and witnesses on the same street tend to stay quiet.

Local ordinance violations are usually [truck accident lawyer](#) easier to establish, which is why the first questions are about where the dog was and whether anyone contacted animal control.

This evidence does not last. Animal control files and witness memory both degrade, and the dog itself may be gone before anyone captures what it had done before.
