

When someone is shocked or burned on a job site in Atlanta, several companies may share responsibility.

There is the property owner, the general contractor, the electrical subcontractor, sometimes the utility, occasionally an equipment maker, and sometimes a staffing agency. Each has different insurance and different incentives to point at the others.

Workers compensation pays medical bills and a portion of lost income when the injury is work related, and it bars a suit against your employer. It does not bar a claim against a third party whose conduct created the hazard.

That third party claim is usually where the real recovery sits, because comp does not pay for pain, disfigurement, or the full economic loss of a career that [personal injury accident lawyer](#) ended early.

Establishing who controlled the hazard requires the site contracts and the safety documentation, none of which an injured worker can obtain by asking.
