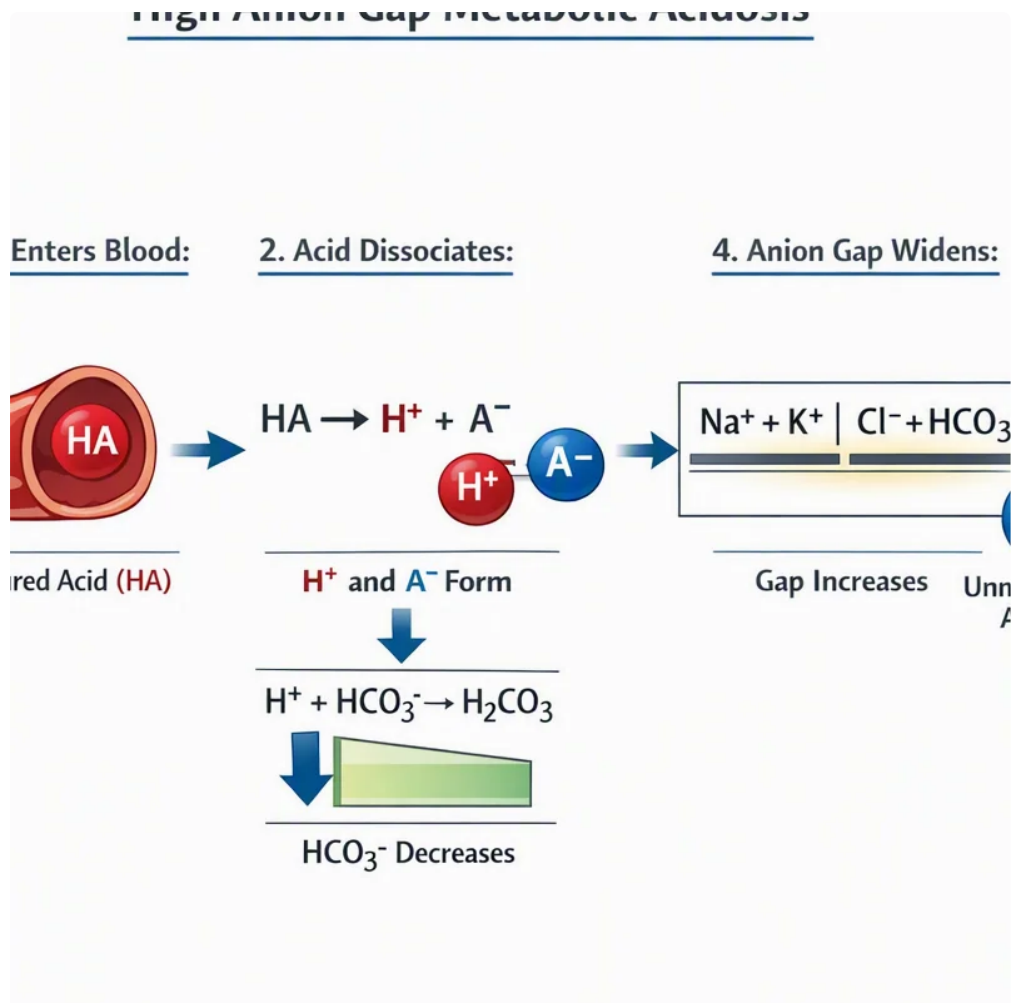


What the Anion Gap Shows in DKA

The **anion gap** is a lab-based value that helps determine the origin of **metabolic acidosis**. In **diabetic ketoacidosis**, it is especially useful because it indicates the accumulation of acids that are not directly measured on a standard chemistry panel. This renders the anion gap a useful **diagnostic tool** for recognizing **high anion gap metabolic acidosis**.

Chloride-related acidosis can occur during or after DKA treatment, especially after large volumes of chloride-containing fluids.
