When the app is off, the driver is just a driver, and their personal policy applies. Once the app is on and the driver is waiting for a request, a smaller layer of coverage generally applies. Once a ride is accepted or a passenger is aboard, a far larger commercial policy usually applies.

That timing is not a small detail. It can decide whether the coverage available is modest or substantial, and the app data that establishes it belongs to the rideshare company.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer. Trucking companies often send their own investigators to the scene within hours, and evidence such as onboard data and camera footage can be overwritten or lost in days.
