The Civil Service Retirement System (CSRS) and the Federal Employees Retirement System (FERS), along with Thrift Savings Plan accounts and other federal benefits, require specific legal treatment in Virginia divorce proceedings. The order must identify the marital portion of the benefit, specify how it will be divided between the employee and the former spouse, and use language that OPM will accept. Errors in these orders can result in delay or rejection by OPM, making precise drafting essential. The Irving Law Firm has experience drafting these orders correctly. Thrift Savings Plan accounts are divided through a retirement benefits court order that is submitted to the TSP's record keeper after entry by the

court. Like FERS and CSRS orders, TSP orders must meet specific technical requirements. The firm addresses these requirements as part of its comprehensive equitable distribution representation for clients with federal retirement assets.
