

If you or your child were bitten around Atlanta, the rules may not be what you assume.

Some states hold the owner responsible no matter what. Georgia is not one of them. The claim generally turns on whether the owner knew the animal was dangerous, or whether the dog was loose in violation of a local leash ordinance.

Proving prior knowledge is difficult. Owners rarely volunteer that a dog has snapped before, and neighbors are often reluctant to get involved.

The ordinance route is frequently more provable, which is why the first questions are about where the dog was [truck accident lawyer](#) and whether anyone contacted animal control.

Records disappear quickly here. County records and recollections both fade, and the animal may be rehomed or euthanized before its history is ever documented.
