

A rideshare wreck raises a question a normal car crash does not: whose insurance actually pays. The answer turns on what the app was doing when the crash happened.

When the app is off, the driver is just a driver, and their personal policy applies. Once the app is on and the driver is waiting for a request, a limited amount of coverage usually applies. Once they have accepted a ride or have a passenger in the car, a far larger commercial policy usually applies.

That timing is not a small detail. It can decide whether the coverage available is modest or substantial, and the records that prove it sit with the rideshare company, not with you.

How much does a personal injury lawyer cost in Atlanta?

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer. Trucking companies often send their own investigators to the scene within hours, and evidence such as onboard data and camera footage can be overwritten or lost in days.
