

When a rider is hurt and someone turned across your path around Atlanta, you are starting from behind.

Sometimes it fits. More often a driver looked and did not register a single headlight.

The work is physical evidence, not story, since the story is doubted before it is told. Sight line analysis do the arguing.

Injury severity cuts both ways. There is nothing around a rider, so the same impact produces far worse injuries. Expect an argument that choosing to ride was itself the risk.
