

What the Gap Measures in Acid-Base Balance

The **anion gap** is a useful way to examine **acid-base balance** using standard **electrolytes** from a serum chemistry panel. It can estimate the difference between measured positive and negative ions, which can suggest an underlying acid-base disorder that is not obvious from pH alone. How do you calculate the anion gap for albumin?
