

If you were hurt after a fall in Georgia, the case turns on something most people do not expect. Showing the spill was there is only half of it.

Under Georgia law you generally have to show that the business knew or should have known, created it, or would have discovered it by inspecting the way a careful owner should.

Which is why the opening weeks decide these cases. Camera footage cycles in a matter of days at many businesses, and without it you cannot establish how long the condition existed.

Incident reports come from the business itself, which affects what ends up in them. Sweep logs matter just as much, since a written policy that was ignored says a great deal.
