

If a dog bit you in the Atlanta area, Georgia works differently than people expect.

Some states hold the owner responsible no matter what. Georgia is not one of them. The question is normally whether the owner had reason to know the dog was vicious, or whether a leash law was being broken at the time.

Proving prior knowledge is difficult. Owners rarely volunteer that a dog has snapped before, and neighbors are often reluctant to get involved.

A leash law violation is often the clearer path, so the early questions focus on whether the animal was restrained and whether anyone contacted animal control.

Records disappear quickly here. Animal control files and recollections both fade, and the dog itself may be gone before anyone captures what it had done before.
