

If you were riding and were hit around Atlanta, you are starting from behind.

Adjusters and jurors bring an assumption to these cases: that the rider was going too fast, was weaving through traffic, or accepted a risk nobody else would.

Occasionally that is true. Usually the car turned left across a rider who had the right of way.

Reconstruction matters more here than testimony, because narrative starts at a disadvantage. Scene measurements carry more weight than either version of events.

Severity helps and hurts. A rider has no structure around them, so identical forces cause much greater harm. The defense response is often to argue the rider accepted that risk by riding at all.
