That timing is not a small detail. It can decide whether the coverage available is modest or substantial, and the app data that establishes it belongs to the rideshare company.

Whether you were riding, driving another car, walking or on a bike changes the analysis too. Each position can reach **truck crash lawyer** a different layer of coverage.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer. Trucking companies often send their own investigators to the scene within hours, and evidence such as onboard data and camera footage can be overwritten or lost in days.
