

If you were hurt by electrical contact around Atlanta, there is usually more than one responsible party.

A site has an owner, the general contractor, the electrical sub, sometimes the utility, sometimes an equipment manufacturer, and sometimes a staffing agency. Each has different insurance and different incentives to point at the others.

If the injury happened at work, workers compensation covers medical treatment and part of your lost wages, and it prevents you from suing the employer directly. It does not bar a claim against a third party whose conduct created the hazard.

That third party claim is usually where the real recovery sits, because comp does not pay for pain, disfigurement, or the full [truck accident lawyer](#) economic loss of a career that ended early.

Working out who was responsible means getting the contracts, the safety plan [affordable car wreck lawyer](#) and the daily logs, none of which an injured worker can obtain by asking.
