

What Is the Anion Gap?

The **anion gap** is a calculated value used to help interpret **serum electrolytes** on a basic **electrolyte panel** and broader **blood chemistry** testing. 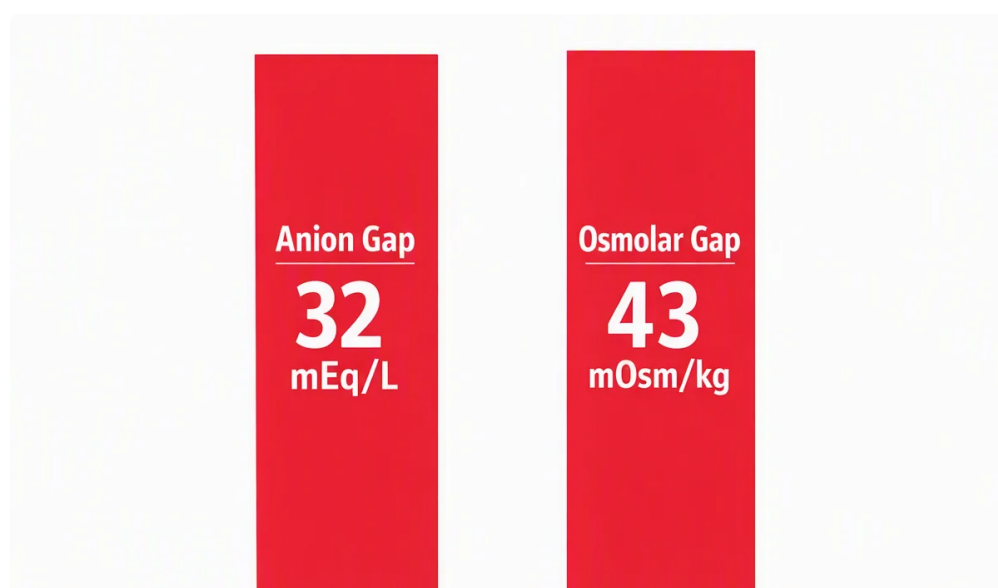
