

A rideshare wreck raises a question a normal car crash does not: which insurance policy actually applies. The answer depends on what the driver was doing at that exact moment.

When the app is off, the driver is just a driver, and only the personal policy is in play. Once the app is on and the driver is waiting for a request, a limited amount of coverage usually applies. Once they have accepted a ride or have a passenger in the car, a much larger commercial policy typically comes into play.

That timing is not a technicality. It can be the <https://atavi.com/share/y0jrrqz1ipdcq> difference between a modest policy and a substantial one, and the records that prove it sit with the rideshare company, not with you.

It matters whether you were the passenger, the other driver, a pedestrian or a cyclist. Each one can reach different policies.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
